

Explanation of Financial Aid Satisfactory Academic Progress Statuses

Good Standing

Great Work! You are in Financial Aid Good Standing. To remain in Good Standing you must continue to maintain an overall Grade Point Average (GPA) of 2.0 or higher **and** an overall pace of completion of 67% or higher. Your pace of completion is determined by dividing your total earned credit hours by your total attempted hours (**which include successfully completed courses, Repeats, Withdrawals, Incompletes, Failures and transfer hours.**).

GS-Approaching Max CR Hrs

Good Standing/Approaching Maximum Timeframe

You may not be able to complete your academic program within the timeframe allowed due to the number of credit hours you have already attempted. **Attempted credit hours include successfully completed courses, Repeats, Withdrawals, Incompletes, Failures and transfer hours.** You should meet with an Academic Advisor in to insure you are on schedule with completing your academic program within a timely manner.

Suspension-Completion %
